# Non-Key experts required for the EU funded project "EU for Natura 2000 in Serbia" – 4 positions

The project "EU for Natura 2000 in Serbia" is funded by the European Union, managed by the Delegation of the European Union to the Republic of Serbia, and implemented by a consortium led by Eptisa Southeast Europe d.o.o. Main institutional beneficiaries of the project are the Ministry of Environmental Protection and Institute for Nature Conservation of Serbia. The overall objective of the project is to assist the Republic of Serbia to carry out preparation for establishment of Natura 2000 network, in context of the preparation for EU accession. The project will be implemented in the period May 2019 – May 2021, and includes 5 main results:

- 1. Designation process for potential SPAs ad pSCIs substantially completed, according to the Birds and Habitats Directives, for Natura 2000 network;
- 2. Information System, Database and GIS for Natura 2000 developed;
- 3. Harmonization of national legislation with EU directives related to nature protection revised and completed;
- 4. Technical and administrative capacity for implementation of nature protection legislation strengthened;
- 5. Public awareness campaign for Natura 2000 implemented.

# 1. OVERALL PURPOSE OF THE ASSIGNMENT

Senior bird species non-key expert will contribute to the objectives of the project by reviewing existing information; carrying out desktop analyses on bird species; carrying out and supervising field work on bird species; developing criteria for potential SPA; contributing to the selection of potential Natura sites; deciding on boundaries of sites; preparing training plans (short-term, long-term); implementing short-term training plan; providing inputs to the institutional development plan and assisting the Key Expert 2 in the field of Bird species.

# 2. SCOPE OF WORK

The expert will be engaged within Result 1, 2 and 5 of the project (Result 1 – Designation process for potential SPAs and pSCIs substantially completed according to the Birds and Habitat directives, for Natura 2000 network; Result 2 – Information system, Data base and GIS for Natura 2000 is developed; Result 4 – Technical and administrative capacity for implement of nature protection legislation strengthened; Result 5 - Public awareness campaign for NATURA 2000 is implemented) and within the following project activities with reference to the project ToR:
