Article 1 Subject

1.1 The subject of the contract is the supply, delivery, customisation, installation and commissioning by the Contractor of the following goods:

in two lots at the place of delivery indicated in Annex II+III "Technical Specifications + Technical Offer". The time limits for delivery and the implementation period of the tasks shall be 5 months from the commencement date to the date for provisional acceptance for lot 1 and 2, and the Incoterm applicable shall be DDP⁴.

- 1.2 The Contractor shall comply strictly with the terms of the Special Conditions and the technical annex.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the Special Conditions.

A certificate of origin for the goods must be provided by the Contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be <.....euros>.
- 3.2 Payments shall be made in accordance with the General and/or Special Conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the Special Conditions
- the General Conditions (Annex I);
- the Technical Specifications (Annex II [including clarifications before the deadline for submission of tenders];

- the Technical Offer (Annex III [including clarifications from the tenderer provided during tender evaluation]);
- the budget breakdown (Annex IV);
- specified forms and other relevant documents (Annex V):
 - LEF
 - FIF
 - Performance guarantee
 - Pre-financing guarantee
 - provisional/final acceptance certificate

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.


