3.	Container is made from Polyethylene (HD-PE!) (Advantage: corrosion free, light weight; 1.7 kg container only!) Please put an option to be able to offer Polyethylene container. No manometer (but a red marking on bleeder valve will indicate the max. pressure. If pressure is too low, then the operator will realise that by having a poor spray volume and this will indicate, to pump up the sprayer again.) Please confirm if this specification is acceptable.	Please follow the requirements of the technical specifications from tender dossier.

Container washing set: No certificates are available, since the sprayer does not fall under the European Regulation for pressure devices # 97/23/EG. <u>So please omit</u> <u>this requirement from the</u> <u>specifications.</u>	The UN standard is available on line.
