1. Background information

Overall objective of the project:

The overall objective is to contribute to smart, sustainable and inclusive growth for the Republic of Serbia by building a more knowledgeable and skilled labour force, promoting social inclusion of vulnerable populations and enabling greater opportunities for a better standard of living in alignment with the targets set forth by the Europe 2020 Strategy.

Challenges and needs addressed by the project

The overall developments on the Serbian labour market are not substantially different from the pattern observed in most transition countries. Most employment and unemployment problems are structural rather than cyclical. Low level of employment, high level of unemployment, especially among the young and the old, and high rate of inactivity are all connected with the structural changes in the economy that is related to the transition from mainly public to private sector employment and to the rising emphasis on productivity and efficiency.

‘Serbia needs to address structural rigidities on the labour market, including the mismatch between demand for and supply of skilled workforce.

Purpose 1- To reduce labour market skills mismatches by improving NES¹ existing training system

Purpose 2- To improve impact of employment measures and services tailored to the needs of persons with disabilities
