1.1 DESCRIPTION OF THE ASSIGNMENT – Senior non key expert on assessment the progress in the Education sector reform related to quality and relevance of education in the preschool, primary, secondary and higher education areas

### **Project background**

The project has as main objective to assist the Government of Serbia in implementing reforms in the education sector by improving the quality, equity and relevance of the education and training. Actually the project provides assessment of the compliance of the Ministry of Education, Science and Technology Development (MoESTD) with the General and Specific Conditions for the release of fixed and variable tranches as set out in the Annex I a of the Financing Agreement for the "Sector Reform in Contract for Education Reform in Serbia strengthening links with employment and social inclusion" and to provide recommendations to the EU Delegation to the Republic of Serbia on the achievement of the indicators for the fixed and variable tranches and the value of the tranches to be disbursed. The main results that have to be achieved are 1) ensuring the capability of EUD to determine the extent of progress achieved in the implementation of education reforms, and in particular in the context of SRC contract performance and 2) ensuring the capability of EUD to conduct an informed policy dialogue under the SRC, in particular on issues related to Roma inclusion and education in minority languages; 3) assessment of the financial support provided to Republic of Serbia from IPA I and IPA II in the field of education and promotion of this support.

## Objectives of the assignment

The assignment will contribute to the achievement of the first project result. The main expected outcome of this assignment is elaboration of an assessment report on the progress made in the implementation of the Action Plan to the Education Strategy in the year 2019 related to quality and relevance of education in the pre-school, primary, secondary and higher education areas. The assessment has to cover the following main areas — undertaken activities and level of achievement of the measures in the Action plan, achievement of the Public Policy Eligibility and Performance Indicators, policy framework and legislative framework, policy credibility, policy financing, institutional capacity, ownership and reform coordination, achievement of variable tranches indicators and respect of the cross cutting issues in the policy implementation. The assessment will aslo review the develoments related to the NQF system in Serbia (institutional, legal and financial framework for NQF system), with this having been in place and referenced to the EQF for the year 2019.

- 2. Review of all available documents and collected data related to the progress made in the pre-school, primary, secondary and higher education areas of the Education reform;
