1.	Item 1 Vehicles Compact off- road, point 6 of the technical specifications: 'Power Transmission: 7. Reduction: two-degree reduction without differential lock'. Please clarify if you require a separate two speed transfer case? Please if separate 2 speed transfer case is required, then remove the requirement for origin for the vehicle as there is no compliant origin vehicle of this specification. Alternatively, please allow that we offer six – speed manual gearbox with short staged first gear.	•

Item 2 Vehicles 4x4 Pick Up – please allow that we offer engine 5b+ which is currently accepted and imported in accordance with the local rules and regulations in Serbia and other countries from the Balkan region.	Please note that the requirements for Item 1.2 "Vehicles – 4x4 Pick Up double cabin", as specified in the Technical Specifications are: Engine 5. Diesel engine, min² Euro 6
3.	Please confirm that open frame type generators which comply with EC Directives for sound and safety will be acceptable	Please note that the required level of protection for Item 2.1 "Generators" as specified in the Technical Specifications under line 7, is: Intended service 7. Command box casing (enclosure of the electronic equipment) with the Ingress Protection rating 23 (IP23)
