Lot 1

Due to the reduction in the mass of the vehicle, and with the aim of lower emissions of co2 "Peugeot Automobiles", the vehicle incorporates either a spare wheel of a smaller cross-section or a reparation set.

Lot 2

Due to the harmonization of the aggregates with the WLTP standard instead of the 1.6 (1560 cc) aggregate from the entry of 6.2 standards in "Peugeot Automobiles", the units are 1.5 (1499 ccm) identical power.

Will you appreciate the offer if we offer a vehicle with an aggregate of 1499 cc?

Item 1: City Vehicle:

- Full-size spare wheel
