The offer must be clear enough to allow the evaluators to make an easy comparison between the requested specifications and the offered specifications.

1. PROJECT DESCRIPTION

The purpose of this contract is purchase of vehicles, office furniture, IT equipment, audio-video equipment, as well as surveillance equipment for the Serbian Police authorities, in order to improve their capacities in fight against the trafficking of human beings (THB).

Department for Contracting and Financing of EU Funded Programmes (CFCU) of the Ministry of Finance of the Republic of Serbia is the Contracting Authority responsible for this project. The beneficiary of this Contract (Beneficiary) is the Ministry of Interior.

2. DELIVERY LOCATIONS

- 2.1 The delivery addresses for the equipment which is subject of this contract is specified under point 4 of this technical specification/offer. The Supplier shall agree the installation schedule with the Contracting Authority in consultation with the Beneficiary. The Beneficiary shall guarantee the Supplier's free entrance to the buildings and relevant room(s) during the installation works. The Supplier shall be fully responsible for its equipment until the provisional acceptance has been issued.

3. GENERAL PROVISIONS

3.1. General Requirements

- 3.1.2. All the equipment shall be provided brand new, complete with the necessary accessories and/or parts such as to ensure that the unit is capable of operating to the required technical and quality specifications.
- 3.1.3. Equipment which allows upgrading of capacities shall be provided in such a way that upgrades can be performed by installing additional capacity without discarding the already installed capacities.

3.2. Power supply standard

Unless otherwise stated in the Detailed Technical Specifications, all electrical equipment should be powered with 220V, 50Hz AC. All devices must be compliant with Serbian and European Union electrical safety standards and follow EEC CE Marking Directive.

3.3. Post-Completion Documentation

Where required, the Contractor will be responsible for preparation of Technical Post-Completion Documentation describing the system implemented. It should include graphical description of interconnection between various elements, all hardware and software configuration details, start-up scripts and a description of mandatory maintenance procedures to be followed by the Beneficiary during day-to-day operation of the equipment. The Post-completion Documentation will be subject to approval of the Contracting Authority.

Commercial warranty: Commercial warranty for this Lot is minimum 12 months, starting from the date of issuance of Final Acceptance Certificate.
